Mr. Clepper made a motion, seconded by Mr. Slifko, that the Board appoints Stock and Leader, LLP, with Mr. Philip H. Spare, as principal counselor, to serve as South Middleton School District's Solicitor for the 2010-2011 school year. The proposed fees for the 2010-2011 school year are to continue without an annual retainer and an hourly rate of \$155 for partners and \$145 for associates, unless otherwise agreed for special projects such as negotiations or litigation. Bond issues and similar financing matters will continue to be billed on a transactional basis. **The motion passed unanimously**.

Ms. Martin made a motion, seconded by Mr. Clepper, that the Board approves all of the following in a block motion:

The Board authorized the Principal of the W.G. Rice Elementary School to complete the necessary scheduling and release arrangements to permit the Cumberland County Area Bible Club to conduct a released time religious instruction program off-campus for the third grade students for one hour a week during the 2010-2011 school year.

The Board approved the Alternative Education for Disruptive Youth agreement between Manito, Inc., at 7564 Brown's Mill Road in Chambersburg, PA and the South Middleton School District for 0 seats for the 2010-2011 school year.

The Board approved a one-year contract agreement with Therabilities, a pediatric therapy agency, to provide occupational and physical therapy services to eligible students attending the South Middleton School District. The contract agreement is for 108 days of occupational therapy at a per diem rate of \$494.00 and 250 hours of physical therapy at an hourly rate of \$70.00.

The Board That the Board approves the Alternative Education for Disruptive Youth agreement between River Rock Academy and the South Middleton School District for ten seats for the 2010-2011 school year. Six seats will be at the Shiremanstown school and four seats at the Carlisle school. The total cost to the District is \$212,454.

The Board approved the Purchase of Service Agreement between Northwestern Human Services of PA, NHS Autism School and the South Middleton School District for the provision of classroom services for the 2010-2011 school year at a cost to the District of \$24,760.80 per student plus the cost of any related service, i.e., speech therapy, occupational therapy, etc., or an individual aide, if required by the IEP.

The Board approved the Support Staff Employee Compensation and Benefit Plan from July 1, 2010 through June 30, 2014, with salary increases as follows:
