Mrs. Capozzi stated that the Education Committee met earlier this evening and reviewed student enrollment, the Keystone Exams, final evaluations for inclusion of School Performance Profile and student learning objectives.

FACILITIES COMMITTEE - Mr. Berk

Mr. Berk reported that the Facilities Committee met earlier this evening and reviewed the status of the Iron Forge Educational project, summer help, the building/grounds budget for 2014-2015, the 2013-2015 now report., the 5-year plan, and the upcoming Act 34 hearing.

TOPIC DISCUSSION

The following items were topics of discussion on the agenda:

- Healthcare Funding Options Tina Darchicourt spoke about the current and future health care options for the district.
- Preliminary Budget Dr. Mancuso spoke about principal responsibilities and the needs at Rice. Mr. Berk spoke in support of a second guidance at YBMS. Mr. Hayes stated that he supported Mr. Berk's statement. Dr. Mancuso also spoke about a possible 6th grade teaching position due to enrollment numbers, a multi-disability class that will be budget neutral, since it will be bring back students that are currently placed outside the district. This multi-disability classroom will include 1 teacher and two aides. Dr. Moyer commented on the excellent work Mr. Bitner does at YBMS, assisting with the guidance department.

Mr. Berk made a motion, seconded by Mrs. Capozzi, that the Board approves the adoption of the 2014-2015 preliminary budget as follows:

That the Board of School Directors of the South Middleton School District, Cumberland County, Pennsylvania hereby tentatively adopts the annual budget, transfers and designations of and for said District for the fiscal year commencing July 1, 2014, as more fully set forth in PDE Form 2028 which is presented at this meeting:

Further, that said Board of School Directors hereby authorizes the expenditure of \$32,253,387, including a budgetary reserve of \$500,000, for the school fiscal year July 1, 2014 through June 30, 2015, and more particularly and fully detailed in the proposed annual budget as foresaid; and

Further, that said Board of School Directors does hereby levy a real estate tax of 9.0982 Mills of the assessed valuation (\$.90982 per \$100 of assessed value)) on all real estate within the South Middleton School District, pursuant to the authority of "The Public School Code of 1949," as amended for the fiscal year as aforesaid; and

Further, that said Board of School Directors continues to levy the following taxes heretofore levied pursuant to the authority of "The Local Tax Enabling Act," as amended (1) Realty Transfer Tax $-\frac{1}{2}$ %; (2) Earned Income Tax $-\frac{1}{2}$ 1.1%; and (3) Occupational Privilege tax - \$10.00.

That the proposed taxes levied and continued to be levied shall provide revenue for the proposed expenditures authorized above.
